#### **Investment Considerations**

- The Company generates revenue from two key areas:
  - *Installation (53% of 2017 revenue):* The Company performs all installation work in-house. However, any related stucco and framing work is subcontracted.
  - *Materials (27%):* The Company positions itself as a supplier and installer for a wide range of glass products including commercial store front systems, glass doors, skylights, screens, shower and tub enclosures, and table and desk tops.
- **Strong Customer Relationships:** Management has focused efforts on expanding relationships with property managers and contractors. The Company generates an estimated 75% of revenue from repeat customers.
