THE REASON FOR SELLING

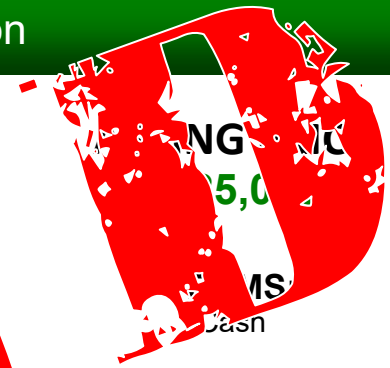
The owners enjoy the business and all the benefits it provides but are ready to retire.
