## THE REASON FOR SELLING

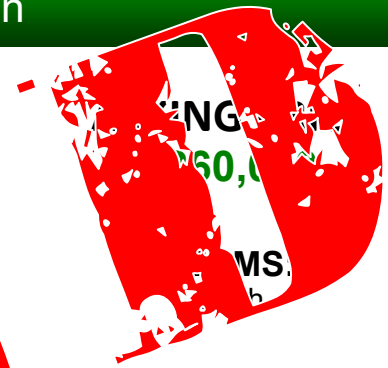
The Owner enjoys the business but is now ready to sell this flagship location.
