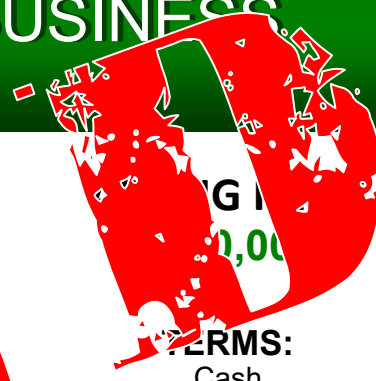
After 25+ years in the business, the owners wish to retire. The owners are offering up to two months of on-site training as part of the sale.
