Revenue has grown 35% over the past three years to \$1,037,000, with the beer and wine café continuing to ramp revenue. The business comes complete with all equipment, website, brand, established customer base, and all startup expenses in place for the expansion.

THE LOCATION

This location, in one of Idaho's best loved resort communities, is central in the McCall community with easy access to all sectors of the McCall impact area. The location offers convenient ingress, egress and parking for diners, take out customers, friends meeting for refreshments at the bar, on the patio or the recently completed deck. The building, built in 1991, has been completely updated since 2010 with electrical, plumbing, roofing, and other infrastructure improvements to support the restaurant and café operations.

THE STRENGTHS

This opportunity is unique in many ways. It is widely regarded as best of its type of cuisine in the area, includes a second concept on site, and includes the real estate to make a complete diversified revenue stream that covers all seasons in this fast-growing area. It has been extremely well managed with involved owners and the employees love working here; a critical advantage in a workforce constrained resort region. This is really a unique opportunity to own a profitable McCall Institution and the valuable land it sits on.
