In addition, they provide waste removal for special events that involve animals. There are currently 326 residential customers and 23 commercial accounts. There are eight full-time Scoopers/Workers. The Franchise company provides advertising, first page Google placement, automated online customer sign-up, accounts receivables, scheduling, route organizing and billing. It is a "turnkey" operation that could seamlessly transfer to a new owner.

THE LOCATION

The company is home based and serves Boise, Meridian and Kuna. The system used for scheduling automatically organizes routes based on the Scooper's (worker's) home location.

THE STRENGTHS

This company has consistently been the Boise leader for pet waste removal since its inception. There is a large, loyal customer base that has been using the service for many years. In addition, the franchise model and resources make it very simple for a new owner to assume this business.

THE REASON FOR SELLING

The current owners are interested in pursuing other opportunities in a different state. One of the Franchise requirements is the owner must live in the market it serves.
