### THE IDEAL BUYER



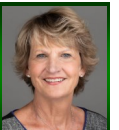
